OFFICE MEMORANDUM

Subject: Monitoring and Coordination of the implementation of Jan Shikshan Sansthans (JSS) scheme of Ministry of Skill Development and Entrepreneurship (MSDE) by respective Regional Directorates of Skill Development and Entrepreneurship (RDSDE) reg.

The scheme of Jan Shikshan Sansthan is being implemented through Jan Shikshan Sansthans (JSSs) across the country to achieve the goal of Skill India Mission of the Government of India. The scheme aims to provide skill training in a non-formal mode at the doorsteps of the beneficiary through registered Societies (NGOs) with 100% grant from the Government of India. The priority groups under the scheme are women, SCs, STs, OBCs and minorities in the rural areas and urban low-income areas. Presently, there are 290 JSSs across 26 States and 7 UTs. (List of Active JSSs State-wise District-wise is enclosed)

2. In accordance with JSS Scheme guidelines (enclosed) and vide RDSDE Gazette dated 20.11.2019 (Regd. No. D. L.-33004/99), at the State level, the Regional Directorate of Skill Development and Entrepreneurship (RDSDEs) under the Directorate General of Training (DGT), has been assigned the task of monitoring and supervision of the JSS centers under their jurisdiction by undertaking periodic visits of the JSS centers. Further, in order to improve the functioning of JSSs, vide this Ministry's OM dated 21.02.2024, the Regional Directors of RDSDEs or his/her representative, has been designated as Nominee of Joint Secretary, MSDE in the Board of Management (BoM) of the JSSs of the respective State.

3. Therefore, in order to strengthen and streamline the functioning of the Jan Shikshan Sansthans (JSSs) in accordance with the JSS Scheme guidelines, the RDSDEs are hereby requested to undertake periodical visit of JSSs under their territorial jurisdiction and to submit the visit report to this Ministry (email at jss.pmu-msde@gov.in and djssjamnagar@gmail.com) within one-week of the date of their visit. The format of the visit report of the JSSs covering various parameters for review is enclosed. Further, for effective improvement of JSS, the RDSDE shall ensure the compliance of remedial measures by the JSS within one month.
